Each person or entity that is GST registered should nominate the applicable ABN. You must advise RWA as soon as you become registered for GST and provide them with your ABN if you haven't already done so.
- ! Please note that the information you provide should only relate to the ownership/lease of the horse/greyhound. We do not require details of another enterprise you may have (e.g., plumbing, farming) unless your horse/greyhound is combined with this enterprise.
- ! In the case of syndicate members who are GST registered, it is the GST status of the syndicate that will apply and not that of the individual syndicate members.
- ! Unless this form is provided with all relevant information, it cannot be processed, and all payments will be withheld until complete details are received. Please note that RWA is obligated to withhold the top rate of tax from the payment and remit to the ATO if an ABN, or requisite statement by Supplier, is not provided.

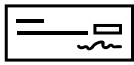
