If I am applying for a trainer's licence, I acknowledge my application will be rejected if I do not have public liability insurance. 4. If I am charged with an offence punishable by fine or imprisonment I undertake to contact the Stewards immediately upon being charged. 5. If I have been convicted of an offence punishable by fine or imprisonment in the previous 12-months, I undertake to contact the Stewards (08 9445 5570) immediately and attach to this application a copy of my current Police Clearance Certificate and details of the Court ruling in relation to the offence. 6. I shall at all times conduct and present myself in a professional and proper manner and comply with the RWWA Rules of Thoroughbred Racing, Official's instructions and the powers afforded to them and that failure to do so can place my current and future involvement in the industry in jeopardy. 7. I acknowledge having read and understood the said Rules and further undertake to read the Official RWWA publications so as to keep myself informed of any amendments to the said Rules or any other Regulations, Conditions and Directions made by RWWA. 8. I agree to be bound at all times by the said Rules in force from time to time and any other lawful Rules. Regulations, Conditions and Directions as may from time to time be formed, made or given by Stewards or Officials of RWWA, 9, 1 acknowledge that in the event of becoming disgualified. CONDITIONS APPLICABLE TO A STABLE FOREPERSON LICENCE

The following are preconditions to the granting of this particular category of licence to a person;

- Has five years of practical experience reasonably required to carry on the vocation of a trainer, including (but not limited to) experience in attendance to and performance of duties involving the handling of thoroughbred racehorses at stables, track work, trials and race meetings
- Is of good reputation and character and is a fit and proper person to hold a Stable Foreperson's licence.
- · Passes the written and practical examination and interview conducted by the Stewards
- Demonstrates to the Stewards his/her competency in horse handling and saddling.
- Must be a permanent resident of Australia
- Payment of a one off fee

Without in any way limiting the power of RWWA to prescribe terms and conditions in respect of a Stable Foreperson Licence, this category of licence is unless otherwise determined by RWWA, subject to the conditions specified:

Stable Foreperson application:

- Must be currently licensed as a Stablehand, Trackwork Rider or Trainer
- Must be a minimum of 18 years of age
- A letter from the nominating trainer as to why a Stable Foreperson's licence is required

A Stable Foreperson licence may be limited as to duration or locality or both. A Stable Foreperson licence is only issued, and valid, for the Trainer listed in the application. Upon receipt of written advice from the listed Trainer or the Stable Foreperson that a person is no longer the Stable Foreperson, for that Trainer, the Stable Foreperson licence held by that person is automatically cancelled. Subject to the previous clause every Stable Foreperson licence shall expire on the thirty-first day of July in each year. Should you be granted a Stable Foreperson licence and be unable to attend a race meeting where any horse trained by your trainer is engaged, the Trainer shall nominate another licensed trainer to be responsible for such horse at the meeting. A trainer or holder of a licence to train or owner/trainer licence shall not, without having made written application and obtained the consent of the Stewards, stable any horse trained by him or her in any location other than his registered stable address as notified on this application or subsequent renewal.

Where an initial application for a Stable Foreperson licence is rejected, no further application shall be considered for a period of 6-months from the date of rejection of the first application. A person who has had a second application for a Stable Foreperson licence rejected within 12-months of the rejection of the initial application shall have no further application considered for a period of 12-months from the date of rejection of the second application. Should that or any subsequent application be rejected any further application shall not be considered for 12-months thereafter unless, the person is specifically invited to make application.

RWWA may refuse to consider or grant any application for a Stable Foreperson licence until it is satisfied that any direction or condition that it may require as a prerequisite to the granting of such licence has been satisfied.

A person holding a Stable Foreperson licence shall not permit a person who is not the holder of a current Track Work Rider licence to ride track work on a racecourse or training track.

APPLICANT'S DECLARATION

We acknowledge that a Stable Foreperson licence is only issued, and valid, for the Trainer listed in the application. Upon receipt of written advice from the listed Trainer or the Stable Foreperson that a person is no longer the Stable Foreperson for that Trainer the Stable Foreperson's licence held by that person is automatically cancelled. If the Stable Foreperson leaves the employ of a Trainer we acknowledge that such Trainer and Stable Foreperson must advise RWWA of such in writing.
