- Any alterations to the transfer must be initialled by the Manager (correction fluid or tape will render the transfer invalid).
- A Manager must be appointed when there is more than one transferee. The Manager must be a Transferee.
- If any transfer is being signed under Power of Attorney or Letter of Authority, a copy of such authority must be provided when lodging the transfer.

 has been registered with Racing WA or an approved Racing Controlling Body shall within 10 days of purchasing the Greyhound make
 application to Racing WA.
- Transfers of ownership must be lodged with the Controlling Authority in the State in which the incoming managing owner resides. A
 Transfer of Ownership is not official until approved and signed by the Racing Services Officer of Racing WA in whose area the
 Greyhound is to race.
- It is a requirement that all persons listed below are the holders of a current owner's registration/licence from the Controlling Body in the State/Territory in which they reside.
- The first named person appearing in the acquiring section shall be recorded as the **Racing Manager** and all correspondence and payments shall be sent to that person unless otherwise stated.
- · All members of a group must complete and sign. If a syndicate, the Manager and one other member must sign.
- A completed Racing WA Notification of Financial Details form must be lodged with this transfer by the Manager
- Any alterations to this form must be initialled by the Manager, correction fluid or tape will render the form unacceptable.
