NAMING GUIDELINES – HARNESS

Please familiarise yourself with the following rules and requirements for the naming of your horse, prior to submitting a naming application, as additional fees may apply in some circumstances.

Please note that horses may be named as soon as DNA parentage is confirmed.

Naming Fees - 1 August 2023 - 31 July 2024

Standard Naming Fee	\$74.00
Additional Fee – Urgent Requests	\$14.00
Additional Fee – Submit New List (if all original submissions rejected)	\$18.00



Naming Rules - Australian Rules of Harness Racing

The following are General Rules to be followed when applying to name a horse.

- A maximum of 18 characters (including spaces) in any name. A minimum of three (3) names must be submitted.
 Note, an additional fee will be charged to resubmit a list of names to HRA if the first names presented are rejected, it is therefore recommended that the full six (6) name requests are submitted in the first instance.
- At least 10 working days should be allowed for the processing of a naming application.
- Apostrophes, abbreviations, initials, trade names and names of persons (living or dead) will not be accepted
- The Central Registrar (HRA) and the Harness Registration Officer reserve the right to reject any name.
